

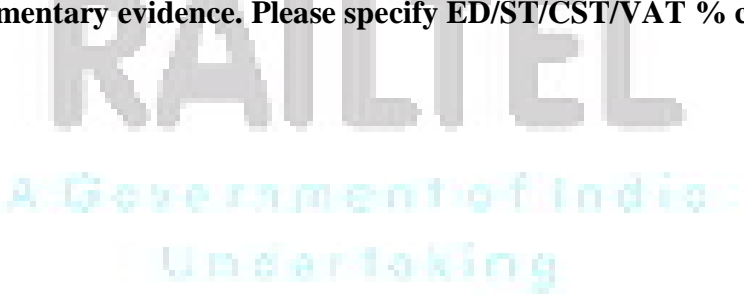

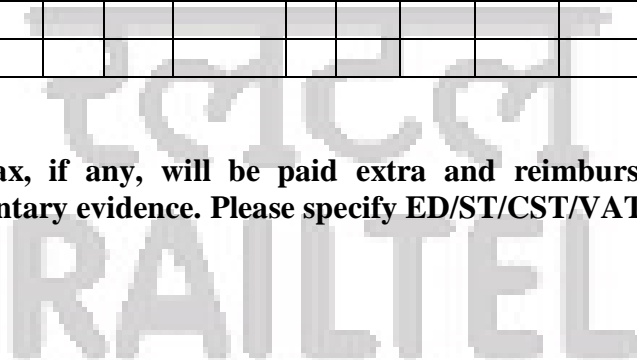

## CHAPTER III

### Commercial Terms & Conditions

#### **1. Offer letter and Validity of Offer**

- 1.1 The bidder shall complete the offer letter and the price schedule furnished in the bid documents, indicating the goods to be supplied, description of the goods, associated technical literature, quantity and prices etc. For the items not manufactured by bidders, the authorization from original manufacturer should be enclosed.
- 1.2 Bidder should enclose their credentials including supply of similar material to other government/PSUs/ Telecom Service Providers.
- 1.3 The Excise registration is required to avail CENVAT Credit, tenderer should be registered with SSIC or Excise department. The documentary evidence for the same should be enclosed along with the offer. However, in absence of documentary evidence or certificate, the offer is summarily rejected.
- 1.4 The offer should remain valid for a period of **90 days** from the date of opening.

#### **2. Warranty**

- 2.1 The materials are to be warranted for **15 months** from date of delivery or **12 months** from Date of Installation whichever is earlier. The bidder shall warrant that stores to be supplied shall be new and free from all defects and faults in material, workmanship and manufacture and shall be of the highest grade and consistent with the established and generally accepted standards of materials of the type ordered and shall perform in full conformity with the specifications and drawings. The contractor shall be responsible for any defects that may develop under the conditions provided in tender and under proper use, arising from faulty materials, design or workmanship such as corrosion, inadequate quantity of material to meet requirements, inadequate protection, deficiencies in circuit design and / or otherwise and shall remedy such defects at his own cost when called upon to do so by the Purchaser who shall state in writing in what respect the stores are faulty.
- 2.2 If it becomes necessary for the contractor to replace or renew any defective portion/portions of the material under this clause, the provisions of the clause shall apply to the portion/portions of the material so replaced or renewed or until the end of the above mentioned period of twenty four months, whichever may be later, if any defect is not remedied within a reasonable time, the Purchaser may proceed accordingly at the contractor's risk and expenses, but without prejudice to any rights which the Purchaser may have against the contractor in respect of such defects.
- 2.3 Replacement under warranty clause shall be made by the contractor free of all charges at site including freight, insurance and other incidental charges.



**3. Delivery of material:**

The Materials should be supplied, installed & commissioned within **60 days** of issue of “Purchase Order” and should be delivered to the consignees as per Purchase Order. The materials are required to be delivered in Delhi, Uttar Pradesh, Rajasthan and Punjab.

**4. Payment Terms**

4.1 80% of the value of the part supply of the set (Battery charger plus Battery set) on receipt by the consignee at site duly inspected and accompanied with the following documents:

(i) Invoice (ii) Delivery Challan (iii) Contractor’s certificate of dispatch (iv) Excise duty payment gate pass (v) Inspection certificate in original with Good receipt No. (GRN) generated from ERP. (vi) Consignee’s receipt (vii) Warranty guarantee certificate of OEM (viii) Undertaking against Fall Clause.

4.2 10% value of the part supply on successfully Installation & Commissioning at site and submission of I&C report dully signed by RailTel Executive.

4.3 Balance 10% payment will be released after full supply and successful installation & commissioning at site of full material.

**5. Performance Bank Guarantee (PBG)**

The supplier is required to submit a Performance Bank Guarantee (PBG) within 15 days of issue of Purchase Order for **10 % of the value of the order and valid for a period of 4 months beyond warranty period towards satisfactory performance of tender clauses.** The PBG shall be returned after successful completion of contractual obligation. The Performa for PBG is given in Chapter IV. The PBG will be forfeited if the order is terminated by the Purchaser on account of Contractor.

**6. Taxes & Duties**

Please see clause 18.

**7. Liquidated Damages**

The timely delivery is the essence of this project, Liquidated damages will be applicable at the rate of half percent per week or part thereof for undelivered portion subject to a maximum of **10 % of the cost of supply.** RailTel will have the right to cancel the order, place order on alternative source at risk & cost of the supplier besides levying the L.D.

**8. Transportation**

The rates quoted should be F.O.R. destination.

**9. Statutory Deduction**

These will be made at source as per the rules prevalent in the area of work.

**10. Issue of Purchase Order/Award of Contract**

The purchaser shall consider placement of orders for commercial supplies on those bidder whose offers have been found technically and commercially acceptable. The rates quoted by the bidders shall be compared/evaluated itemwise and the Purchase order for each item of the SOR shall be placed on lowest bidder for each item. The issue of purchase order shall constitute the award of contract on the bidder. The bidder shall within 7 days of issue of Purchase Order, give his acceptance along with Performance Bank Guarantee as per Clause 5.

**11. Purchaser's Right to Vary Quantities**

The Purchaser reserves the right at the time of award of order/contract to **increase or decrease** by **upto 25 %** of the quantity of goods and services specified in the Schedule of Requirements without any change in unit price of the ordered quantity or other terms and conditions.

**12. Splitting of Order**

Deleted.

**13. Purchaser's Right to accept any Bid and to reject any or all Bids**

The purchaser reserves the right to accept or reject any Bid and to annul the bidding process and reject all bids, at any time prior to award of contract without any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds for the Purchaser's action.

**14. Issue of Advance Purchase Order - Deleted**

**15. Issue of Purchase Order and Award of contract – Please see Clause 10.**

**16. Annulment of Award**

Failure of the successful bidder to comply with the requirement of Clause 5 shall constitute sufficient ground for the annulment of the award and forfeiture of EMD in which event the Purchaser may make the award to any other bidder at the discretion of the Purchaser or call for new bids.

**17. Earnest Money Deposit (EMD)**

Earnest Money as per Tender Notice shall be submitted in the form of Demand Draft from any Nationalized / Scheduled bank in India in favour of "RailTel Corporation of India Ltd. payable at New Delhi." EMD may be forfeited if a bidder withdraws his offer or modifies the terms and conditions of the offer before validity period and in the case of a successful bidder, if the bidder fails to accept the Purchase Order and furnish performance security in accordance with clause 5 and 10.

17.1 Tenders under noted categories of tenderers need not deposit Earnest money :-

- a) Firm registered with NSIC up to the monetary limit of their registration for the items tendered.
- b) Deleted

17.2 Money of the unsuccessful bidder will be discharged/returned as promptly as possible. No interest shall be payable on the EMD.

17.3 The successful bidder's bid security will be discharged upon the bidder's acceptance of the purchase order satisfactorily and furnishing the performance bank guarantee in accordance with **clause 5**.

17.4 Tenders not accompanied by Earnest money shall be summarily rejected.

## **18. BID PRICES, Taxes & Duties**

18.1 The bidder shall give the total composite price inclusive of all levies and taxes, packing, forwarding, freight and insurance etc. **The basic unit price and all other components of price need to be individually indicated against the goods it proposes to supply under the tender as per schedule given in Chapter II.** The price shall be firm in Indian Rupees and FOR Destination. No Foreign exchange will be made available by the purchaser. Sales Tax Form "C" shall be provided by RailTel.

18.2 The break up of price of each item of SOR in terms of basic Unit price, Excise duty, Sales Tax, Freight, Forwarding, Packing, Insurance and any other Levies/charges already paid or payable by the supplier shall also be quoted separately.

18.3 The price quoted by the bidder shall remain fixed during the entire period of contract and shall not be subject to variation on any account.

## **19. Clause wise Compliance**

Clause wise compliance statement of the Technical Specifications and Commercial Terms & Conditions shall be enclosed with the offer along with technical literature of the material and other documents in support of relevant clauses.

## **20. Provenness of the material/equipment supplied:**

In order to enable the Purchaser to assess the provenness of the materials offered, the bidder shall provide documentary evidence regarding the materials being offered by him.

**21. Training - Deleted.**

**22. Inspection**

- 22.1** Pre-shipment/pre-dispatch inspection shall be carried out at manufacturer's / supplier's works by authorized representative of RailTel's. The materials should be offered for inspection within 2 to 3 weeks of issue of Purchase Order. Traveling, lodging & boarding expenses of RailTel's representative and charges for 3<sup>rd</sup> party inspection, if any, shall be borne by RailTel but necessary facilities to carry out tests / witness inspection shall be provided by the manufacturer, free of cost.
- 22.2** Along with inspection call, the supplier / manufacturer shall submit details of test procedures, test programme, test parameters together with permitted values, etc. and their Quality Assurance Plan.
- 22.3** In case material fails during inspection, the same shall be replaced, free of cost, by manufacturer/supplier. In such a case, total cost of re-inspection including travel, lodging & boarding of the inspecting officials shall be to manufacturer's/supplier's account.

Nominated RailTel Engineer will issue inspection certificate of successfully completion of the test/inspection.

**23. Force Majeure**

Force majeure shall mean -

- War, hostilities (whether war be declared or not), invasion, act of foreign enemies.
- Rebellion, revolution, insurrection or military or usurped power, or civil war.
- Ionizing radiation, or contamination by radio-activity from any nuclear fuel, or from any nuclear waste from the combustion of nuclear fuel, radio active toxic explosive or other hazardous properties of any explosive nuclear assembly or nuclear component thereof.
- Presume waves caused by aircraft or other aerial devices traveling at sonic or supersonic speeds.
- Riot, commotion or disorder, unless solely restricted to employees of the Contractor or of his Subcontractors and arising from the conduct of the works.
- Loss or damage due to the use or occupation by the Employer of any section or part of the permanent works, except as may be provided for in the contract.
- Loss or damage due to the extent that it is due to the design of the works, other than any part of the design provided by the contractor or for which the contractor is responsible, and
- Any operation of the forces of nature against which an experienced contractor could not reasonably have been expected to take precautions.

**24. Settlement of Disputes**

**24.1 For all commercial contracts with Private entities:**

In case of any dispute concerning this order both the supplier and RailTel shall try to settle the same amicably through mutual discussion/negotiations. Any unsettled dispute shall be settled in terms of Indian Act of Arbitration and conciliation 1996 or any amendment thereof. Place of arbitration shall be New Delhi. Arbitrator shall be appointed by Managing Director, RailTel Corporation of India Limited.

**24.2 For all commercial contracts with Public Enterprises/ Govt. Departments:**

In the event of any dispute or difference relating to the interpretation and application of the provisions of the contracts, such dispute or difference shall be referred by either party for Arbitration to the sole Arbitrator in the Department of Public Enterprises to be nominated by the Secretary to the Government of India in-charge of the Department of Public Enterprise. The Arbitration and Conciliation Act, 1996 shall not be applicable to arbitration under this clause. The award of the Arbitrator shall be binding upon the parties to the dispute, provided, however, any party aggrieved by such award may make a further reference for setting aside or revision of the award to the Law Secretary, Department of Legal Affairs, Ministry of Law & Justice, Government of India. Upon such reference the dispute shall be decided by the Law Secretary or the Special Secretary/Additional Secretary, when so authorized by the Law Secretary, whose decision shall bind the Parties finally and conclusively. The Parties to the dispute will share equally the cost of arbitration as intimated by the Arbitrator

**25. Governing Laws**

This contract shall be interpreted in accordance with the laws of India. The courts at New Delhi shall have exclusive jurisdiction to entertain and try all matters arising out of this contract.

**26. Termination for Default**

The purchaser may without prejudice to any other remedy for breach of contract, by written notice of default, sent to the supplier, terminate this order/contract in whole or in part.

- a) If the supplier fails to deliver any or all of the goods within the time period(s) specified in the order/contract.
- b) If the supplier fails to perform any other obligation(s) under the contract; and
- c) If the supplier, in either of the above circumstance(s) does not remedy his failure within a period of 30 days (or such longer period as the Purchaser may authorize in writing) after receipt of the default notice from the purchaser.

In the event the purchaser terminates the order/contract in whole or in part, the Purchaser may proceed, upon such terms and in such manner as it deems appropriate, goods similar to those undelivered and the supplier shall be liable to the Purchaser for any excess cost for such similar goods. However, the supplier shall continue performance of the order/contract to the extent not terminated.

**27. Termination for Insolvency**

The purchaser may at any time terminate the order/contract by giving written notice to the supplier, without compensation to the supplier, if the supplier becomes bankrupt or otherwise insolvent as declared by the competent court provided that such termination will not prejudice or affect to the Purchaser.

**29. Submission of Tender Bid (Single Packet System):**

29.1 The envelope shall be addressed to the Purchaser at the following address:

29.2 Earnest Money Deposit (EMD) equal to **Rs 29,500/- (Rupees Twenty Nine Thousand Five Hundred Only)** in the form of Account Payee Bank Draft in favour of RailTel Corporation of India Limited, payable at New Delhi, should be enclosed with the tender bid. The envelope containing the bid should be sealed by the personal seal of the bidder. **Each and every page of the bid should be numbered and signed by authorized representative of the firm.** Power of attorney in favour of the signatory duly authorizing the signatory shall be enclosed with the bid.

29.3 **The Tender document issued by RailTel should be signed on each page along with stamp of the company/Firm and should be submitted along with bid.**

29.4 The envelope shall bear **name of the supply, the tender no. and the words “DO NOT OPEN BEFORE” (due date).**

29.5 Bid should be delivered to the above address so as to reach up to **15:00 hours of 16.08.2016** The bids shall be opened at **15:30** hours on the same day in the above office in the presence of those representative of the bidders who choose to be present. Bids received after due date and time shall be summarily rejected and shall not be opened. If the above said date happens to be a holiday the same shall be done on the next working day.

**30.0 UNIT PRICES**

30.1 The prices quoted by the Tenderer shall include the prices of materials including all incidental charges for transport, loading/unloading and handling of materials, charging for arranging dispatch by rail/road direct from manufacturer's factory. The prices would also include charges towards completing all necessary formalities such as submission of forwarding notes, arranging placement of Wagon, Siding/shunt charges, banker's charges for Bank guarantee, Indemnity Bonds inclusive of cost of Stamp etc. as applicable and also the charges, if any, levied by the RailTel.

30.2 The prices shall include all taxes, duties, Royalty and levies (including, Custom Duty with/without High Sea Sale etc.) applicable on this contract. Therefore, the bidder should quote their prices taking into account the rate of central sales tax/local sales tax/ VAT or any other tax leviable on contract. The breakup of price of each item of SOR in terms of

basic Unit price, Excise duty, Sales Tax, Freight, Custom Duty, Forwarding, Packing, Insurance and any other Levies/charges already paid or payable by the tenderer shall be quoted in the SOR. Any changes in statutory duties/taxes after opening of technical bid will be to RailTel's account within the contracted delivery period.

The Octroi/entry tax shall be paid extra as per actual on production of proof of payment/document.

Form-C will be issued by RailTel for items in Schedule of Supplies, if applicable.

- 30.3 The prices quoted by the tenderer shall include cost of commissioning and testing and all costs of Administration of Contract, Insurance Premium, Banker's charges for guarantees, custom handling, cost of storage in custom and other locations during execution of work, loading-unloading and handling of materials and road transport which the contractor may use for carriage of materials to his depot/ site of work and any other charges incurred towards delivery of the material at site. The prices shall include the cost of works and adjustments necessary to be done by the contractor during or after tests carried out by the purchaser.
- 30.4 The price to be quoted by the tenderers should take into account the credit availed on inputs under the CENVAT scheme. The tenderers should give a declaration that any set off in respect of duties on inputs as admissible under law is being totally and unconditionally passed on to the purchaser in the price quoted by him (see para 43). The bidder in this regard shall submit the details of breakup of Excise Duty, Counter Vailing Duty, Service Tax and Surcharge & Cess on these, so that RailTel can avail the CENVAT credit benefit. The firm will furnish documentary evidence of such duties/taxes paid, to enable the purchaser to avail CENVAT credit.
- 30.5 The prices quoted in the contract shall be inclusive of all taxes i.e. custom duty, excise duty, local levies, sales tax levied by any statutory authority, VAT or any other tax. The tenderer will indicate the details of taxes included in the unit price. Offer received without specific details/ breakup of various taxes included in the unit prices are liable to be summarily rejected.
- 30.6 The purchaser shall make statutory deductions if required to do so. The deducted amount shall be remitted to the concerned authority and the purchaser shall in no way be responsible for any disputes between such authorities and the contractor in this regard.
- 30.7 All taxes, duties and levies arising out of the transaction between the contractor and his sub contractor/supplier for this work will be included in the rates quoted by the contractor in the relevant Schedule.
- 30.8 Arrangement for all permits/licenses required for delivery of materials at site including Road Permits etc. will be the responsibility of contractor and the contractor will have to make his own arrangements. RailTel shall facilitate by way of authorization /request letters whenever needed. Import license of RailTel can be used for materials procured under high sea sale.

**31.0 Fall Back Clause:**

The order/contract, if and when placed, will be subject to following **Fall Back Clause:-**

- 31.1** The price quoted by the supplier should not be higher than the maximum price, if any, for the materials and the same shall not be higher than the price usually charged by the supplier for materials of the same nature, class or description to any other purchaser.
- 31.2** The price charged for the materials supplied under the order/contract by the supplier shall in no event exceed the lowest price at which the supplier sells the materials of identical description to any other person during the period till performance of all supply orders placed during the currency of the contract is completed. If at any time during the period the supplier reduces the sale price of such materials or sells such materials to any other person including his dealers at a price lower than the price chargeable under the contract, he shall forthwith notify such reduction or sale to the purchase and the price payable under the contract for these materials supplied after the date of coming into force of such reduction or sale shall stand correspondingly reduced.
- 31.3 If it is discovered that the supplier has contravened the above conditions, then without prejudice to any other action which might be taken against him, it shall be lawful for the purchaser to terminate the order/contract and purchase the materials at the risk and cost of the supplier and in that event the provision of General Conditions of tender shall, as far as possible, be applicable or recover the loss.
- 31.4 **The Contractor shall furnish the following certificate to the concerned Account Officer along with each bill for payment of supplies made against the order/contract:**

“I/We certify that there has been no reduction in sale price of the stores of description identical to the stores supplied to the Government under the contract herein and such stores have not been offered/sold by me/us to any person /organization including the purchaser or any Department of Central Government or any Railway Office or any Railway Undertaking as the case may be up to the date of bill/the date of completion of supplies against all supply orders placed during the currency of the order/contract at a price lower than the price charged to the RailTel, Northern Region, under the contract.”

## Chapter V

### SCOPE OF WORK AND TECHNICAL SPECIFICATIONS

#### (A) Scope of work for supply, installation & commissioning of ACs:

1. RailTel Corporation of India Ltd., Northern Region is IP-I, IP-II licence holder and having its PoPs for delivering of Bandwidths, Co-locations for BTS etc. Mostly, the PoPs are located at important Railway Stations.
2. The Air conditioning equipments are required to be installed and commissioned at these PoPs. The PoPs may be of Masonary structure or porta cabins. There are certain PoPs which are located on 2<sup>nd</sup> or 3<sup>rd</sup> Floor of Railway Building. RailTel may change the location of PoP where ACs are required to be provided.
3. For the installation of the Air conditioning equipments the contractor has to make arrangements for all the material etc. required for the successful commissioning of the ACs. No extra cost will be paid except quoted by the contractor in SOR.
4. The installation should be of very high standard which is generally acceptable in Telecom fields.
5. The contractor should satisfy himself about the Ground realities in connection with the installation of the equipments before quoting the rates.
6. The AC equipments are to be installed in Masonry Building/Porta cabins. The contractor should satisfy himself for the installation of the AC at various locations as mentioned in Annexure-C.
7. Installation at site includes preparation of opening of window and doing complete work of finishing wall as per original condition. This also includes supply of all other electrical/ civil materials required for installation (i.e. wire, MCB, Stand, Plug top etc.).

#### (B) Description of Window & Split AC (As per DGS & D):

1. Air conditioners suitable for 230V, 50 Hz single phase AC supply shall be capable of performing the functions as cooling, dehumidifying, air circulating and filtering. The Air conditioners may either be provided with adjustable step less type mechanical thermostat or electronic thermostat as per IS: 11338:1985.
2. Outdoor unit of the air conditioners shall be fitted discharge cooled type rotary/sroll type compressor operating on Refrigerant R-22 (or non-CFC refrigerant R-410A in case of Split Air Conditioner) with suitably rated capacitor start electric motor. It shall be equipped with overload protection and shall be mounted on resilient mountings for quiet operation.
3. Remote cordless control with LCD/LED Display shall be provided with one On/Off timer, selecting fan speed (three speeds) and setting up of temperature. Display shall be provided on indoor unit or on handset or on both.
4. Air conditioners shall be provided with standard 5 mtrs refrigerent Cu pipe, electrical wire and drainage pipe.

5. Servicing: Free servicing shall be provided for 15 months from the date of dispatch or 12 months from the date of installation of air conditioner whichever is earlier. Firm is also required to send service engineer at least 3 times during the warranty period.

6. Warrantee: Warrantees shall be provided for 15 months from the date of dispatch or 12 months from the date of installation of air conditioner, whichever is earlier.

7. Installation: The installation charges shall include the following work:-

i) Mounting/Fitting indoor and outdoor units at the respective locations.

ii) Laying refrigerant piping of required length and connecting both the units after drilling hole/holes in the wall, if required.

iii) Leak testing of the entire system.

iv) Charging Refrigerant gas in the unit.

v) Suitable electric wiring between indoors and outdoors units of required length up to switch at location of indoor unit. Switches/ Sockets /Plugs are not included in the scope of supply.
